- a condition for an increase in investment in energy infrastructure and competition development
- market development has to be encouraged
- various obstacles in the electricity and gas market

Legal Framework

- 1) EU 3rd Energy package, directives and regulationes
- 2) Decisions of the SEE Ministerial Council
- **3) 2014 Energy Law**
- Bylaws are in preparation and adoption process

The new Energy Law

- Approved in December 2014
- 3rd EU Energy package
 - Directives inserted into EL
 - Regulations incorporated as a mandatory content of by-laws
- Other national laws (public enterprises, activities of general interest, public procurement)
- Precisely defined competences and responsibilities of relevant institutions, operators and market participants
- Strengthened the independence of the Agency and expanded jurisdiction

Regulatory body (AERS)

The Regulatory body (AERS)


- Established in 2005 by the 2004 EL
- Agency functioning is independent of:
 - state executive authorities and other state bodies and organizations
 - Legal and natural persons engaged in energy activities
 - 2014 EL expanded the competence and strengthened its independence
- Reviews of the Agency work:
 - Competence + international contribution
 - Independence





TSO & DSO Role at the Market

- Guarantees the ability and accuracy of measurements –importance of unbulding
- Maintains a database of suppliers, contracted metering points and the expiration date of the contract
- Informs the Public and the Last resort suppliers if the measuring point is not covered by contract
- Provides metering data to customers and their suppliers
- Load profiles

Final customer's supply contract

- > Full supply
 - customer pays for the quantity consumed during calculation period
 - for a definite or indefinite period


Households have full supply contracts!

- > Supply with quantity determined in advance
 - customer pays for the contracted quantity
 - for a definite or indefinite period

At one metering point, they can not be combined!

Supplier switching rules

- Adopted in July 2015 Agency
- In accordance with the 2014 EL (3rd EU Energy package)
- Basic characteristics:
 - it defines the conditions and procedure
 - common rules for electricity and gas
 - customer's contract on full supply
 - obligations and deadlines for: selected new supplier, system operator, current supplier and final customer
 - switching procedure is launched by a customer who finds a more favourable supplier by filing an application to a new supplier
 - free of charge for customers
 - takes 21 days max

Final consumption is 28.5 TWh

Market openness is 31% (of final consumption)

Final consumption is 1,981 mil m³

Market openness is 40.6% (of final consumption)

Expected: In 2015, there has been a significant decline in the quantity on the regulated market due to limitation on the consumption of small consumers at 100,000 m³/year

Regulated supply price perspective

Regulated electricity supply price

Current state:

- lower than the economically justified prices
- all eligible costs are covered
- insufficient approved profit for further development

Perspective:

The Agency shall yearly analyse the need for the further prices regulation (the first report until 1 May 2017) on the basis of:

- achieved competitiveness level at domestic market
- accomplished level of protection of energy vulnerable customers
- development of the regional electricity market and
- assessment of available cross-border capacities

Regulated gas supply price

Current state:

- all prices are based on market price of imports and domestic production
- all eligible costs are covered
- approved profit is on the level of the usual values for this type of activity

Perspective:

- Natural variations of market prices
- There is no obligation to move toward the abolition of regulation

Consumers protection

Consumers protection

- Law on Consumer Protection
- Energy Law
 - many provisions defined obligations to protect the rights of consumers
 - the obligations of the suppliers of end customers regarding: human resources, technical equipment, means of communication with consumers, transparency...

Recommended content of the bill

The bill must indicate:

- 1) Network access in line with tariffs
- 2) Energy consumption in line with tariffs

In order to provide a possibility:

- To compare the bids of suppliers
- Of influencing the use-of-system charge by changing the way of spending
